## Key Issues, Vision and Objectives (Paras 3.1 - 4.3 / Pages 10- 24)

Do you have any comments on the key Issues, Vision and Objectives?

The principles of the visions stated are sound.

### Preferred Strategy (Paras 4.4- 4.8 / Pages 25-27)

Do you have any comments on the preferred strategy?

The ratio of affordable homes proposed on private sites is completely unrealistic and not deliverable.

Imposing such high ratios together with zero carbon aspirations beyond building regulations will render sites unviable to deliver.

What ratios have been achieved to date? What ratio was achieved on the strategic site of Lower Chepstow, currently under development, a location that could support affordable/social housing in terms of connectivity jobs and services? We believe less than 5%.

Releasing public land at below market rates to support affordable housing which is eventually sold on at market rates will not solve the problem and may not be publicly supported. Similarly with social housing. Welsh Government funding, CPO's and other such methods will take time to deliver and may not be achievable within the life of the RLDP. Similarly, if social housing is sold on, where does the next supply of housing come from?

### Strategic Policies S1 – Growth Strategy (Paras 4.9- 4.26 / Pages 27-32)

Do you have any comments on Strategic Policy S1 – Growth Strategy

The basic assumption in the RLDP is that there is available capacity in the infrastructure in the south of the County to support further development. That is fundamentally not true and is a fact that can be demonstrated by anybody involved in providing services to residents (roads, drainage, education, health, social care, dentists to name a few).

The number of houses still proposed within the RLDP is still too high particularly in the context of focusing all development in the south of the County. The infrastructure in the south of the County is beyond capacity in every respect, roads, dentist, doctors, broadband. High Beech roundabout in Chepstow has been a major congestion point for many years now and studies are still taking place but with no solution in sight.

A Chepstow by-pass has been discussed for many years now but is no further forwards despite Gloucester County Council proposing 2000 new homes in Beachley and Lydney. With what is proposed in Severnside and Chepstow the settlements will not be capable of

sustaining the quality of living environment we currently enjoy, and that is compromised. Any plan for the Chepstow area has to incorporate the developments that are proposed over
